- **Prevent and respond to the new wave of criminal, civil, and administrative justice problems that is building**, while acting as a platform for people and communities to participate fully in renewal and recovery.
- **Respect people's rights, end abuses of marginalized and disadvantaged groups, and serve communities** in ways that increase trust, promote social cohesion, and enable societies to work together during this emergency.
- Use **principles of openness and accountability** in order to strengthen the justice sector in the longer term, particularly its ability to help people obtain access to information about the law and their rights, and obtain redress and remedy for the injustices that affect their lives.
